

What's Next After Completing Your Membership Renewal?

Completing your annual Standards Self-Assessment to renew your SRE Network Membership is just the first step in your SRE journey for the year ahead. Here are some of the next steps to continue your journey:

1. Review and discuss your results.

Upon the confirmation of your membership renewal, you received a side-by-side report comparing your 2021 and 2022 responses to the Standards

Self-Assessment (SSA). We encourage you to review the similarities and differences with your leadership team and invite you to use the following prompts to guide your discussion:

- How has your organization grown in your SRE journey in the last year? Where did your responses reflect improvement or decline?
- What barriers did you face in the last year that may have impacted your growth? How can you address some of those barriers this year?
- In the SSA, you indicated the areas where you are seeing improvement. How will the leadership team you identified prioritize addressing them?
- Next year, what changes do you hope to be able to share in your annual SSA? What support do you need internally and from SRE Network to accomplish those changes?
